

FAMILY REGISTRATION FORM – PIERRE SWIM TEAM (Winter Season 2009-2010)

To join the Pierre Swim Team (**PST**), swimmers must obtain a PST & LSC/USA swimming membership (\$150.00 total for the winter season) and hold a YMCA membership. A swimmer new to PST may practice with the team for a 2-week trial period (Oct 5-Oct 16, 2009) without paying the PST & LSC/USA membership dues or Aquatic Center membership dues. **After October 16th, PST & LSC/USA membership dues must be paid and a YMCA membership obtained for the swimmer to continue to practice with the team.**

CRITERIA FOR ENTRY ON THE TEAM: Any youth age 5-19 yrs considering joining the Pierre Swim Team must have passed Level 3 of the American Red Cross "Learn to Swim" Program **OR** must be able to demonstrate the following skills. **Please indicate by circling yes or no to the following:**
